Terms and Conditions

- 1. DEPOSIT:** A deposit of 50% of entire fee or \$_____ shall be due and payable upon execution of this Agreement. The remaining balance or \$_____ shall be due and payable no later than 7 days prior to performance of this Agreement.
- 2. EXPENSES:** Expenses will include coach airfare and other normal transportation charges and expenditures, local lodging and meals, taxi cab, mileage or limousine fares and any other expenses made necessary by the performer's trip to, presence in, or trip from the city in which the program is presented.
- 3. BREACH:** In the event of breach or cancellation of this Agreement by the client, the performer shall have no obligation to perform this Agreement. A breach includes, but is not limited to, the client's failure or refusal to provide any of the items herein stated, or failure or refusal to make any of the payments as provided herein or to proceed with the engagement. In the event of an Act of God prohibits presentation from taking place, but Speaker has made every attempt to perform, client is responsible for agreed upon fee. Aristocrat Business Training & Development is not responsible for monies lost due to Acts of God.
- 4. CANCELLATION BY CLIENT:** By signing this agreement, total fee becomes payable and due in the event of cancellation by client within 30 days of engagement. All deposits are non-refundable within 60 days of engagement. In the event of cancellation, all expenses incurred up to that date including airfare will be reimbursed by client.
- 5. CANCELLATION BY PERFORMER:** In the event of cancellation of this Agreement by the performer due to illness, Acts of God or an unforeseen emergency, it is understood there shall be no claim for damages by either party to this agreement and Speaker's obligation as to such performance shall be deemed waived. Aristocrat Business Training & Development will attempt to provide a comparable performer that is acceptable to the client or monies already paid will be returned to client.
- 6. VENUE:** Client agrees to provide a well heated, lighted and proper place for the program, in good condition, together with all necessary stage accessories and properties, including microphone and implication systems in proper working condition.
- 7. INDEPENDENT CONTRACTOR:** It is understood that the performer executes this Agreement as an independent contractor and therefore assumes all responsibility for withholding tax, social security, state tax, public liability, and worker's compensation insurance. As an independent contractor, the performer shall have exclusive control over the means, methods and details of fulfilling the obligations stated above.
- 8. ENTIRE AGREEMENT:** This instrument sets forth the entire Agreement among Aristocrat Training and Development, the Client and the Performer. This Agreement may not be modified, waived or discharged in whole or in part except by an instrument in writing signed by the parties hereto.
- 9. ADDITIONAL APPEARANCES:** No additional appearances or activities shall be planned by the client nor expected of the performer unless expressly contained as part of the terms of this Agreement. The fee listed is understood to be for the indicated program only and any additional activities are to be treated independently.
- 10. AUTHORIZATION:** The representative of the client in signing this Agreement warrants that he or she signs as a duly authorized representative of the client.
- 11. GOVERNING LAW:** It is understood that is Agreement is entered and accepted in State of Nevada and that the laws of said state shall govern the terms of this contract.
- 12. RECORDING:** It is understood that absolutely no audio or video recordings are permissible during the performance without the express written consent of the Performer. A master tape will be supplied to Aristocrat Business Training & Development if permission is sought and granted.
